

NC State University Finance and Business Scholarship

NC State University offers a scholarship known as the Finance and Business Scholarship Endowment. The purpose of this endowment is to provide scholarship support for the children of permanent employees in the Office of Finance and Business at NC State University.

The scholarship is awarded annually in accordance with criteria established by the Finance & Business Scholarship Committee, which represents major divisions within the Office of Finance and Business: Campus Enterprises, Centennial Campus Development, Environmental Health and Public Safety, Facilities Division, Financial Services Division, Human Resources, Resource Management, and Treasurer's Office.

The Scholarship Committee is responsible for evaluation of applicants and selection of scholarship recipient.

Criteria/Requirements

To be considered for the 2009 scholarship, your application and transcript must be received at the address below by October 30, 2009.

The Finance and Business Scholarship is available to children of permanent employees of the Office of Finance and Business upon successful completion of twelve (12) hours of undergraduate study with a 2.00 grade point average, or nine (9) hours of graduate study with a 3.00 grade point average.

The applicant must be a full-time undergraduate or graduate student at an accredited four (4) or two (2) year university, college, or community college. Full-time is defined as twelve (12) hours of classes for an undergraduate student; nine (9) hours of classes for a graduate student.

The applicant must request an official transcript from their institution and pay any fee required by their institution for the transcript service.

Applicants will be evaluated on their academics, leadership, and community involvement. If applicants' credentials are substantially equal, we may contact an academic reference, which has been provided by the applicant. The applicant is therefore requested to furnish one academic reference and a telephone number at which this person may be contacted.

If applicants' credentials are still considerably equal, extra consideration will be given to those applicants who demonstrate financial need. To demonstrate financial need, applicants must document their financial status at the time of their application. Either a copy of the applicant's application for federal student aid or a copy of their current federal income tax return is acceptable documentation.

Applicants will not be restricted due to curriculum choice, sex, age, race, ethnic background, religious beliefs, or political affiliation.

We will award one scholarship for 2009 in the amount of \$500 covering one academic year. Applicants may reapply each year.
